





### NOTICE OF REGISTRATION, SELECTION, AND ENROLLMENT No. 14/2024 – PPGCMH/CEFID/UDESC

Opens registration and sets deadlines and procedures for selection and enrollment in Master's and Doctoral Programs in Human Movement Sciences.

The General Director of the Center for Health and Sports Sciences (CEFID), in accordance with Resolution 01/2020/PPGCMH and its amendments, as well as Resolution 13/2014/CONSEPE and its amendments, exercising her powers.

### **RESOLVES:**

To open registration and set procedures for selection and enrollment in the Master's and Doctorate programs in Human Movement Sciences at CEFID/UDESC.

#### 1 REGISTRATIONS

- 1.1 Registrations must be made between **April 22 and June 10, 2024**, exclusively online using the form available on the PPGCMH website and by sending the required documentation, as specified in item 2.1 (and item 2.2 when it's the case), to the PPGCMH e-mail (ppgcmh.cefid@udesc.br).
- 1.2 The candidate must specify on the registration form, in the designated field, whether they wish to apply for affirmative action vacancies in one of the following categories: Black or Brown individuals; Indigenous people; Quilombolas; People with disabilities; Transgender individuals; Refugees or holders of humanitarian visas; People experiencing social vulnerability.
- 1.3 Upon submitting the registration form, the candidate will receive a confirmation e-mail at the registered e-mail address.
- 1.4 PPGCMH will send a confirmation e-mail once the documentation requested in item 2 is received.

### **2 DOCUMENTATION**

- 2.1 Applications will only be accepted from candidates who, in addition to filling out the application form, e-mail the following scanned documents to PPGCMH:
  - a) Dissertation/thesis proposal draft in \*.pdf format, as per the guidelines provided in ANNEX 1:









Lattes Curriculum, according to the CNPq model, in full format and in .pdf format, accompanied, only for scoring purposes in the selection process, by documentation from the period 2020-2024 regarding professional performance in higher education, participation in and/or coordination of research projects, supervision of final course projects, and the production of scientific articles published and/or accepted for publication in journals. All documents must be strictly organized in the order in which the items are presented in the Lattes Curriculum;

- b) Proof of the minimum bibliographic production required for each program (60 points for the Master's degree and 150 points for the Doctorate, based on complete articles published and/or accepted for publication in journals), as specified in ANNEX 2. If the minimum score is not met, a dated and signed acceptance from the professor with whom the candidate intends to register is required (ANNEX 3), applying only for the vacancy of the professor who provided the acceptance;
- c) Term of Commitment from the home institution, when applicable, confirming the candidate's release for at least 20 hours per week to participate in the program (ANNEX 4).
- 2.2 The candidate applying for an affirmative action vacancy must attach to the application, in addition to the requirements listed in item 2.1, the detailed document(s) pertaining to the specific group:
  - a) Black or brown individual: Ethnic-racial self-declaration form (ANNEX 5);
  - b) Indigenous: Ethnic-racial self-declaration form (ANNEX 6) and a certificate of affiliation issued by an indigenous group and signed by local leadership, specifying the particular indigenous community with which the individual identifies (no standard template provided);
  - c) Quilombola: Ethnic-racial self-declaration form (ANNEX 7) and declaration of belonging signed by a duly identified local leader or a document recognizing the community as a remnant of a quilombo (no pre-defined model);
  - d) Individual with disability: Self-declaration form (ANNEX 8) and an updated medical report in \*.pdf format (issued no more than 12 months before the registration opening date for the Selection Process), containing: the full name of the candidate; a clinical description of the disability, including the type and degree of the disability, in accordance with <a href="Law No. 13,146/2015">Law No. 13,146/2015</a>; the corresponding code from the current International Classification of Diseases (ICD); and the identification details (full name, specialty, and professional council registration number) and signature of the doctor. Note: The candidate may request special conditions for the interview in ANNEX 8, which will be reviewed for feasibility by the PPGCMH Board;
  - e) Transvestite or transsexual individual: Self-declaration of transgender identity (transgender, transsexual, or transvestite individuals) (ANNEX 9);
  - f) Person holding a humanitarian visa, seeking asylum or refugee status: permanent or temporary humanitarian visa, issued by the National Immigration Council.
  - g) Individual experiencing social vulnerability: Individuals experiencing social vulnerability: Self-declaration of income (ANNEX 10) and proof of participation in the federal government's University for All Program (PROUNI); or evidence of having received a scholarship or financial aid intended to support undergraduate students from public higher education institutions who experience socioeconomic vulnerability.









2.2.1 Candidates registered for affirmative action vacancies who do not meet the requirements for the category in which they applied will not have their registration approved.

### **3 VACANCIES**

- 3.1 Vacancies for Master's and Doctorate programs will only be available for studies that fall within the area of concentration in Biobehavioral Studies of Human Movement and their respective research lines.
- 3.2 Additional vacancies may be requested by supervising professors and will be reviewed by the PPGCMH Board.
- 3.3 Of the total number of vacancies 62 (sixty-two) specified in this Notice, 13 (thirteen) will be allocated to:
  - a) Black or brown individuals;
  - b) Indigenous individuals;
  - c) Quilombolas;
  - d) Individuals with disability;
  - e) Transvestites and transsexuals;
  - f) Refugees or humanitarian visa holders;
  - g) Individuals experiencing social vulnerability.
- 3.3 Vacancies for supervising professors through open competition (OC) and affirmative action (AA) are distributed according the following table:

- 3.4 3.4 If there are no candidates, an insufficient number of candidates, or if candidates do not pass the selection process for a supervisor's reserved vacancies, these vacancies will be reallocated to the open competition vacancies for that supervisor.
- 3.5 All other rules outlined in this selection process for open competition vacancies also apply to candidates for reserved vacancies, except for those explicitly stated otherwise in this Notice.

### **4 SELECTION**

- 4.1 The selection process will be conducted according to the following stages:
- **Stage 1** Review of the documents submitted by the candidates, which will determine the approval or rejection of the registration.
- **Stage 2** Evaluation of the dissertation/thesis proposal and the Lattes Curriculum, as follows:
  - a) The dissertation/thesis proposal draft will be evaluated based on the criteria outlined in ANNEX 1, and a proposal grade (**PG**) ranging from 0.0 (zero) to 10.0 (ten) will be assigned. Candidates who do not achieve the minimum score of 7.0 in this assessment will be automatically disqualified from the selection process.
  - b) The Lattes Curriculum will be evaluated based on the criteria established in ANNEX 2, covering the period from 2020 to 2024, and will include the following duly verified items: (i) professional performance in higher education; (ii) research and supervision activities (participation/coordination of projects and supervision of completed student projects); (iii) bibliographic production (articles published in indexed journals and/or accepted for publication, and books or book chapters published); and (iv) proficiency in English. There is no need to provide additional data from the Lattes Curriculum. The maximum score for the curriculum is 300 points for the Master's program and 500 points for the Doctoral program. Master's candidates who score 300 points or more and Doctoral candidates who score 500 points or more will receive the maximum grade of 10.0 (ten). The grades of Master's candidates who do not reach 300 points and Doctoral candidates who do not reach 500 points will be calculated proportionally to the maximum score (using a simple rule of three). Therefore, each candidate will be assigned a curriculum grade (CG) from 0.0 to 10.0 in this assessment;
  - c) At the discretion of the professors involved, changes may be made to the professors appointed to guide the research project.









**Stage 3** – Interviews conducted by committees consisting of the professor nominated by the candidate on the application form and professors from the relevant research area, preferably. At this stage, candidates will be assessed based on the following criteria:

- a) Relevant details regarding the candidate's involvement in activities related to the program, within the area of concentration and research line, as assessed by each evaluation committee. The panel will issue a grade (panel grade **PG**) ranging from 0.0 (zero) to 10.0 (ten). Candidates who do not achieve the minimum score of 7.0 in this assessment will be automatically disqualified from the selection process.
- b) Relevant aspects of the candidate's participation in research projects, laboratory work, dedication, and involvement with the program, according to criteria established by the professor and applicable to all candidates, will be scored by the intended supervisor (supervisor grade **SG**) from 0.0 (zero) to 10.0 (ten). Candidates who do not achieve the minimum score of 7.0 (seven) in this assessment will be automatically disqualified from the selection process.
- 4.2 The selection will be conducted according to the following schedule:

4.3 After completing the steps of this selection process, the **candidate's final grade (FG)** will be calculated. The final grade (**FG**) will be determined by the simple average of the









following components: the grade of the dissertation/thesis proposal (**PG**), the curriculum grade (**CG**), the interview grade given by the board (**BG**), and the interview grade given by the supervising professor (**SG**), as follow:

$$FG = \frac{PG + CG + BG + SG}{4}$$

### **5 RESULT**

- 5.1 Successful candidates will be ranked in descending order based on their final grade (**FG**).
- 5.1.1 Candidates applying for affirmative action vacancies who achieve a higher final grade than candidates in the open competition for the same supervisor will fill the open competition vacancies. The affirmative action vacancy will then be offered to the next eligible affirmative action candidate for the same supervisor, following the rank order of the selection process.
- 5.1.2 If a candidate approved for the affirmative action vacancy withdraws, the vacancy will be filled by the next candidate for the affirmative action vacancy approved for this supervisor, following the rank order of the selection process.
- 5.2 The preliminary results of the selection process will be published by **July 3, 2024**, on the PPGCMH website at (<a href="https://www.udesc.br/cefid/ppgcmh">https://www.udesc.br/cefid/ppgcmh</a>).
- 5.3 After the announcement of the official results, the candidate will have until **July 4, 2024**, to submit an appeal (by e-mail to <a href="mailto:ppgcmh.cefid@udesc.br">ppgcmh.cefid@udesc.br</a>) concerning only the grades given by the commission for the Lattes Curriculum (CG), or in cases of explicit non-compliance with the terms of this notice. The results of the appeals will be published by **July 5, 2024** on the PPGCMH website at (<a href="mailto:https://www.udesc.br/cefid/ppgcmh">https://www.udesc.br/cefid/ppgcmh</a>).
- 5.4 Approved and ranked candidates will be selected up to the number of vacancies offered by the indicated teacher and must enroll according to the deadlines and procedures specified in this Notice.









### **6 PRE-ENROLLMENT AND ENROLLMENT**

6.1 Candidates selected up to the number of vacancies offered by the professor must complete the **pre-enrollment from July 8 to 17, 2024**, by sending the following scanned documents to the e-mail of the CEFID Graduate Education Secretariat (secepg.cefid@udesc.br):

### I - Brazilian candidates:

- a) Copy of identity card (RG);
- b) Please provide a copy of any supporting documentation for a legal name change (marriage, establishment or dissolution of a stable union, divorce, or any other scenario involving a change of legal name) if applicable and if the name change occurred after the issuance of the Identity Card;
- c) Copy of the graduation diploma and corresponding academic transcript;
- d) Copy of document proving discharge from the Electoral Court;
- e) Proof of COVID-19 vaccination;
- f) For male candidates, from January 1st of the year they turn 19 (nineteen) to December 31st of the year they turn 45 (forty-five), a document proving that they are up to date with their military obligations is required;
- g) For female candidates aged between 12 and 40, proof of rubella vaccination is required.

Furthermore, only for those selected for the doctoral program:

h) Copy of the master's degree diploma and the corresponding academic transcript.

### II – Foreign candidates:

- a) Birth certificate from the country of origin (with sworn translation);
- b) Copy of passport;
- c) Updated copy of the National Foreigner Registry (RNE) or National Migration Registration Card (CRNM), or a protocol containing the respective number (issued by the Brazilian Federal Police), or a temporary or permanent visa document authorizing study in Brazil;
- d) Copy of the undergraduate diploma and the corresponding academic transcript (for master's or specialization programs), and for doctoral program applicants, a copy of the master's diploma and the corresponding academic transcript;
- e) Proof of COVID-19 vaccination;
- f) For female candidates aged between 12 and 40, proof of rubella vaccination is required.
- 6.2 For candidates who completed their undergraduate program in Brazil, if the diploma is not available, they must present, at the time of pre-enrollment for the Master's program, a certificate of completion of the undergraduate program, including the graduation date.
- 6.3 For candidates who have completed their Master's degree in Brazil, if the diploma is not available, they must present, at the time of pre-enrollment for the Doctoral program, a certificate of completion of the program along with the scheduled date for their Master's thesis defense. This defense must take place by the date of enrollment.
- 6.4 If a diploma, as required by items 6.2 and 6.3, is not available, the declaration of completion must be replaced with the duly registered diploma within a maximum period of









- 12 (twelve) months from the start of the academic semester of the program. Failure to comply will result in dismissal from the program.
- 6.5 In the case of an undergraduate degree obtained abroad, the candidate must submit a copy with a Brazilian consular seal.
- 6.6 For a Master's degree obtained abroad, the candidate must present a diploma recognized through the Carolina Bori Platform/Portal.
- 6.7 The selected candidate who fails to submit all required documentation by the established deadline will irrevocably lose their vacancy. This vacancy may then be immediately filled by the next candidate in the established ranking, according to the interests of PPGCMH.
- 6.9.1 Candidates registered for affirmative action vacancies who do not meet the requirements of the group in which they were classified will not have their enrollment confirmed and/or may have their enrollment canceled at any time. In the event of fraud, the candidate will lose their place in the program at any time and may face applicable legal sanctions, even if they have already started the program.
- 6.10 Only pre-enrollments made directly by the approved candidate, or in exceptional cases, by a designated representative with a legally authorized power of attorney, will be accepted.
- 6.11 After submitting the documentation, candidates will receive instructions regarding the procedures and deadlines for enrolling in the UDESC Academic System and submitting authenticated physical copies (or accompanied by the originals) of the documents listed in item 6.1.

### **7 FINAL PROVISIONS**

- 7.1 This selection process is valid for enrollments for the second academic semester of 2024.
- 7.2 Documentation submitted after the registration period has closed will not be accepted, unless requested by PPGCMH.
- 7.3 PPGCMH reserves the right not to fill expected vacancies.
- 7.4 Any omitted cases will be resolved by the PPGCMH Board, as applicable.

### RESEARCH PROPOSAL DRAFT

The proposal draft must be written in Portuguese and focus on a topic related to the intended area of concentration and research line, as outlined in the UDESC Academic Work Manual, available at: <a href="https://www.udesc.br/bu/manuais">https://www.udesc.br/bu/manuais</a>. The document should include, at a minimum, the following items:

- Cover
- Abstract
- summary
- Introduction (theoretical background, problem formulation, justification, and objectives)
- Methodology (research type, subjects/population and sample, tools, procedures, data processing)
- Timeline
- References
- Annex (optional)

**Formatting:** Maximum limit of 20 pages, Arial 12 pt font, 1.5 line spacing, justified alignment, on A4 paper.

**Assessment:** The proposal draft will be graded on a scale from 0.0 (zero) to 10.0 (ten), based on the following criteria:

- Presentation and formatting;
- Originality of the study and suitability for the area of concentration and research line;
- Proper formulation of the problem;
- Significance of the justification;
- Clarity and precision of the objectives;
- Methodological appropriateness concerning the research type, subjects/samples, instruments, procedures, and data processing;
- Feasibility of the timeline;
- Currency of references and compliance with ABNT standards;
- Quality of scientific writing in terms of clarity, objectivity, internal coherence, and linguistic accuracy.

Note: Candidates who do not achieve a minimum grade of 7.0 in the proposal draft will be automatically disqualified from the selection process.

- Proof of articles published in journals should be provided by presenting copies of the pages that include the name of the journal, the title of the article, the author's name, and the year of publication;
- In cases where complete articles are accepted for publication, proof of authorship will be provided by
  presenting evidence of acceptance that indicates the candidate's authorship. When proof of acceptance
  is an e-mail from the journal to one or more authors, it must clearly identify the candidate as a coauthor. When this identification is unclear, additional supporting documents must be attached, extracted
  from the journal's submission platform, or obtained directly from the journal;
- The maximum score for the curriculum is 300 points for the master's program and 500 points for the doctoral program. Master's candidates who score 300 points or more, and doctoral candidates who score 500 points or more, will receive the maximum grade of 10.0 (ten). The grades of master's candidates who do not reach 300 points and of doctoral candidates who reach 500 points will be calculated proportionally to the maximum score (using a simple rule of three).
