### MEMORANDUM OF UNDERSTANDING

between

# Eskişehir Technical University Eskişehir, Türkiye

and

# The State University of Santa Catarina Florianópolis, Brazil

This Memorandum of Understanding is entered into by Eskişehir Technical University (ESTU hereafter) and The State University of Santa Catarina (UDESC hereafter). Following the discussion between Prof. Dr. Adnan Özcan, the Rector of Eskişehir Technical University, and Prof. Dr. José Fernando Fragalli, the Rector of The State University of Santa Catarina, both universities agree to collaborate in promoting and improving academic cooperation in research, event organization, and staff/student exchange in the fields of mutual interest through appropriate means.

### **ARTICLE I**

The universities (parties) agree on cooperation in education to:

- the development and implementation of joint and/or double degree programs,
- the development and implementation of joint training programs,
- the development and implementation of joint distance/online programs,
- the development and implementation of joint certificate programs,
- exchanging academic information and materials,
- exchanging experiences and know-how on teaching methods.

## **ARTICLE II**

The universities (parties) agree on the cooperation in research to:

- performing and coordination of joint research projects,
- providing post-doctoral research opportunities,
- exchanging scientific and technical information,
- exchanging scientific results in defined subject areas,
- publishing the results in these areas.

## **ARTICLE III**

The universities (parties) agree on cooperation in scientific events to:

- organisation of joint conferences, workshops, seminars (including via Internet),
- exchanging information about conferences and workshops.

### ARTICLE IV

The universities (parties) agree on cooperation in staff and student exchange to:

- exchanging students, faculty, and administrators for educational/training purposes for a predefined period,
- enabling students to take up MSc, PhD, or postgraduate studies at a partner institution,
- exchanging students to carry out a specific project, practical training, or to prepare a thesis,
- exchanging staff to carry out a specific project, practical training, and/or to attend a thesis defense,
- exchanging students under student traineeship schemes,

## ARTICLE V

Ultimate responsibility for this MoU lies with the president/rector of each institution, but administrative responsibility for its administration will be delegated to the following officers at each institution:

## **ARTICLE VI**

This Memorandum of Understanding shall be effective for a period of 5 (five) years from the date of signing unless one of the parties notifies the other in writing to terminate the agreement no later than 6 (six) months to the termination of the agreement. However, the agreement may be amended by the mutual consent of both universities. Unless otherwise stated, this agreement may be extended to another 5 (five) years with both parties' written agreement.
